Cellnex Finance, a wholly-owned subsidiary of Cellnex Telecom, S.A. ("Cellnex"), has successfully completed the pricing of a EUR-denominated bond issuance for an amount of EUR 750 million (with expected ratings of BBB- by Fitch Ratings and BBB- by Standard&Poor's) aimed at qualified investors under its Euro Medium Term Note Programme (EMTN Programme) and guaranteed by Cellnex. The bond is maturing in January 2029 at a coupon of 3.625% payable annually and issued at a price of 99.145% of its nominal value.

The bonds are expected to be listed on the regulated market of Euronext Dublin.

The net proceeds from the issuance will be used for general corporate purposes.
